Back to school with the Blue Angel

200 million exercise books are packed into school bags every year in Germany.

In our back to school campaign, we are raising awareness for the environmental benefits of using recycled paper for school materials. Exercise books and pads made out of 100% recycled paper that are certified with the Blue Angel perform the best by far when it comes to protecting the environment, climate and resources. They use 100% less wood, 70% less water and 60% less energy than comparable products produced using virgin fibres. The Blue Angel is also providing lesson and campaign materials on this subject. Our competition to win an environmentally friendly back to school package for the whole class including exercise books, pads and pens certified with the Blue Angel is also running until 25 September 2020!



Frankfurt Book Fair 2020

Although the Frankfurt Book Fair is only being held digitally, it was of course important for us as an ecolabel to still participate. Publishers can find out what criteria printed matter – such as books – are required to fulfil to be certified with the Blue Angel and what environmental benefits they offer from 14-18 October 2020 via www.buchmesse.de. Printed matter certified with the Blue Angel are made out of recycled paper and are also produced using inks low in harmful substances and low emission adhesives.
